OUR PROGRAMS AND SERVICES ARE EFFECTIVE: 93% OF FAMILIES AND 72% OF INDIVIDUALS COMPLETING AN INTERIM SHELTER PROGRAM SECURED STABLE HOUSING AND WERE EQUIPPED WITH LIFE SKILLS TO SUSTAIN THAT HOUSING.

IN ADDITION, LIFEMOVES PROVIDED 554 HOMELESS INDIVIDUALS WITH DROP-IN SERVICES INCLUDING BASIC NECESSITIES, HOT MEALS, AND CASE MANAGEMENT. BECAUSE OUR CHRONICALLY HOMELESS CLIENTS HAVE LONG HISTORIES OF HOMELESSNESS, MAY HAVE PAST CRIMINAL JUSTICE INVOLVEMENT, AND HAVE DISTANCE FROM THEIR FAMILIES AND SUPPORT NETWORKS, THEY HAVE MANY BARRIERS TO BECOMING STABLY HOUSED AND SUSTAINING THAT HOUSING. OUR OUTREACH AND DROP-IN CASE MANAGERS HELP OUR HOMELESS CLIENTS BRIDGE THOSE BARRIERS TO SECURING AND SUSTAINING STABLE HOUSING.
